- 1) Name of the Post; Consultant
- 2) Number of Post: 1 (one)
- 3) Pay: Rs. 75,000/- per month (consolidated) for retired Eminent Scientist/Professor or Rs.60,000/- per month (consolidated) for the Indian Citizen having at least 60% of marks in M.Sc. and Ph.D in Biotechnology/ Life Science
- 4) Age Limit: Candidate must be within 60-62 (retired Eminent Scientist / Professor) or 45-62 (M.Sc. and Ph.D in Biotechnology/ Life Science) years of age as on the last date of application Date of birth entered in the High School Certificate or equivalent issued by the Board/Council concern will be treated authentic (The date for determining the age limit shall be the closing date for receipt of applications from the candidates)
